Programs: All programs with insufficient registration will be cancelled and a full credit /refund will be issued. Saanich Recreation Services will issue a full credit or refund for withdrawals only, less program supply fees, if the request is received prior to the 1st lesson. Requests after 2nd class will only be granted with the approval of a programmer, for cases of illness supported by a doctor's note, or for compassionate reasons.
