 or Ottawa, on flights between Calgary, Edmonton and Vancouver, as well as on flights
 between Toronto Pearson (YYZ) and LaGuardia (LGA), John F. Kennedy (JFK) or
 Newark (EWR) airports (connecting flights excluded).
- Flights can only be used in sequence from the place of departure specified on the itinerary.

- Cancellations can be made up to 45 minutes prior to departure.
