Note 1 Basic compensation for a Member of the Legislative Assembly (MLA) is established under the *Members' Remuneration and Pensions Act*.

Note 2 Members who hold parliamentary positions receive an additional salary that corresponds to a percentage of their basic compensation. If an MLA concurrently holds two or more positions for which an additional salary is granted, the MLA will receive only the higher amount.

Note 3 Members that hold an executive position in government receive an additional salary that corresponds to a percentage of their basic compensation. Ministerial salaries are subject to a holdback per cent, payable upon meeting the conditions as outlined in the *Balanced Budget and Ministerial Accountability Act*. The amounts held back are not included in this report.
