- Note 1 This report provides details of travel costs that have been processed and paid in the period. ### Note 6 Other Related Expenses

- Note 7 Parliamentary Committee Travel

- Note 8 The amounts of the total travel expenses by individual shown in this report will in some cases differ from the amounts disclosed in the annual *Public Accounts*. The reason is that conference fees are included in this report but not in the *Public Accounts*, and this report does not include any Parliamentary Committee staff travel expenses.
- Note 9 The Clerk and the Sergeant-at-Arms were placed on administrative leave with pay and benefits, on November 20, 2018. The Deputy Clerk and Clerk of Committees was appointed Acting Clerk, and the Deputy Sergeant-at-Arms was appointed Acting Sergeant-at-Arms on November 22, 2018. The Clerk retired on May 16, 2019; the Acting Sergeant-at-Arms retired on May 31, 2019; the Sergeant-at-Arms retired on September 30, 2019. Greg Nelson was appointed Acting Sergeant-at-Arms effective October 8, 2019. Kate Ryan-Lloyd was appointed Clerk on March 2, 2020.
