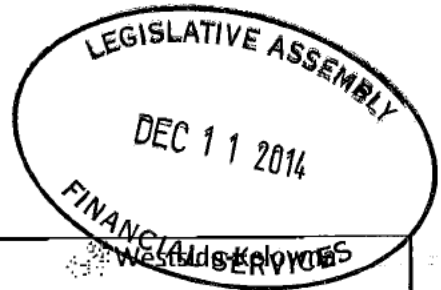
Note 10) Receipts

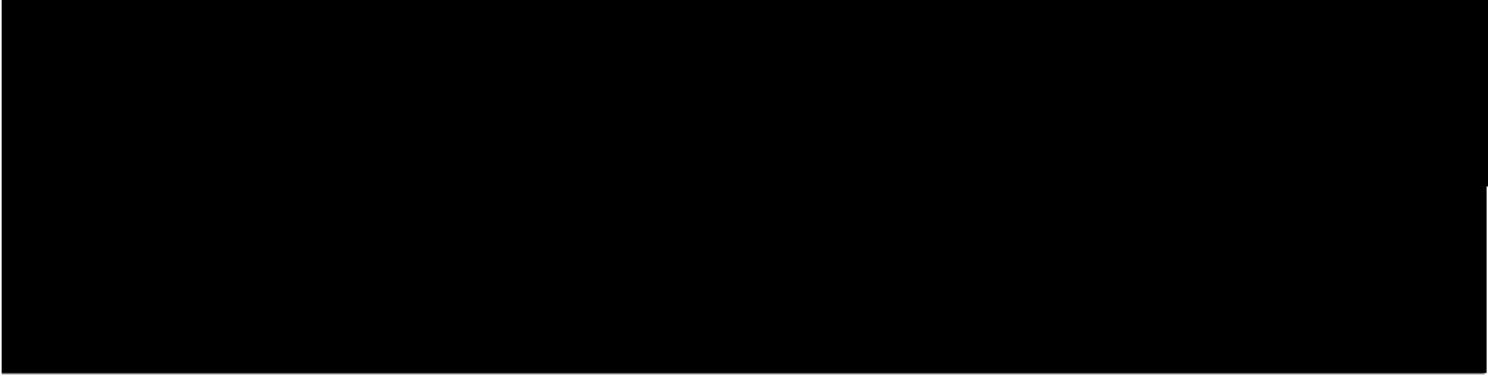
