  - (ii) smoke damage or any other visible sign of fire, or;
  - (iii) an emergency situation; and;
- (b) includes, but is not limited to:
  - the testing of an alarm that results in a Police Department or Fire Department response;
  - (ii) an alarm that is actually or apparently activated by mechanical failure, malfunction or faulty equipment;
  - (iii) an alarm that is activated by user error;
  - (iv) an alarm that is actually or apparently activated by atmospheric conditions, excessive vibrations, or power failures.

If the penalty remains unpaid at the end of the calendar year it will be added and form part of the property taxes as taxes in arrears.

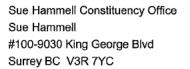
