

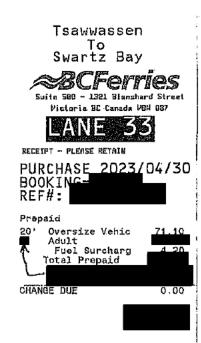
MLA Travel Expenses Paid in the period April 1, 2023 to June 30, 2023

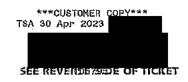
