The Deputy Clerk informed the House of the unavoidable absence of the Speaker, whereupon Mr. *Richard T. Lee*, Deputy Speaker, took the Chair, pursuant to the *Standing Orders of the Legislative Assembly of British Columbia*.

Prayers by Ms. Taylor.

Order called for "Introductions by Youth Parliamentarians."

By leave, on the motion of Mr. *Akombwa*, Bill (No. M 203) intituled *National Identity Act*, *2016* was introduced, read a first time, and *Ordered* to be placed on the Orders of the Day for second reading at the next sitting after today.

Order called for "Youth Parliamentarians' Statements."

Order called for "Oral Questions by Youth Parliamentarians."

Leave not granted to suspend the *Standing Orders of the Eighth Commonwealth Youth Parliament* to extend Oral Question Period.

On the motion of the Hon. *J. Kerr* it was *Ordered* – That *Sheridan Hawse* be appointed Chair of the Committee of the Whole.

On the motion of Mr. *Haughton* it was *Ordered* – That *Elizabeth Kite* be appointed Deputy Chair of the Committee of the Whole.

The House proceeded to "Orders of the Day."

Bill (No. 1) intituled *Youth Apprenticeship and Internship Act* was committed.

Ms. *Ndiritu* moved a proposed sub-amendment to the amendment to add section 4.1 to Bill (No. 1) which passed on the following division:

Mr. *Lynch* moved a proposed amendment to add section 5.1 to Bill (No. 1) which was defeated on the following division:

NAYS - 24YEAS - 19

Bill (No. 1) was reported complete with amendment, read a third time and passed.

The Speaker declared a short recess.

Bill (No. 1) Youth Apprenticeship and Internship Act.
